

CODE OF CONDUCT

I acknowledge that I am a representative of my country and my community. I will conduct myself in accordance with the following rules of conduct so long as I am in the program.

To that end, **I PROMISE:**

- 1. Bring no disgrace.** I will not do anything intentionally to bring disgrace to my country, my community, the sponsoring organizations, my family, guardians or to myself.
- 2. Respect others' property.** While living with a host family, I will treat their property and their community with respect. I understand that if I damage or lose any property belonging to someone else, I will have to pay to have it repaired or replaced. I will ask permission to use, and respect host limits for the use of, telephones, computers and other technology in their home.
- 3. Honor others' sacrifices.** I understand that the host family is not being paid for hosting me. Their reward is the opportunity to get to know about my culture and me. I acknowledge that my hosts are giving of themselves for my personal benefit.
- 4. Try to fit in.** I will try my very best to adapt to life with my host family and their community by getting to know their culture. I understand that my time living with them will be aimed at achieving that end. I will not expect my hosts to emulate my home environment for my comfort.
- 5. Respect others.** I realize that what may be considered acceptable forms of expression may differ between the United States and its sister city. I will remain conscious of that difference. I will make no negative or cruel comments to or about my host's country or community. I acknowledge that in America everyone is considered equal. I will treat everyone with dignity, and I will interact with all people. I will make no disparaging remarks about anyone who is different from me, such as people who belong to a different religion, different race, different national or cultural group, or about persons who are homosexual, who are disabled or who profess political views different from mine. Furthermore, I will not exhibit sexist behavior, but will demonstrate respect for both women and men equally.
- 6. Respect their rules.** I know that my host family has accepted me as a part of their family. I understand that this means I will join in family activities as much as possible and will try as hard as I can to communicate with them. I promise to ask my host family for help if I do not understand what is expected of me. I will ask permission to go places and to do things. I will respect schedules established and curfews imposed. I also understand that I will not reveal – to my friends especially – any private information about my host family.
- 7. Respect authority.** I acknowledge the privilege the program has given to me, and the efforts others have made to make that possible. I will respect that by following the rules and obeying instructions. I will exhibit a positive attitude, actively and willingly participating in activities in the spirit with which they are offered, whether I like the activity or not, and regardless of my state of mind at the time.
- 8. Seek to discover.** I will explore the community I am visiting. However, I cannot expect my host family to be tour guides or to take me on expensive trips around their country. I acknowledge that my time visiting will not be tailored to maximize interaction with fellow travelers from my country.
- 9. Bring problems to YAEP.** I understand that if I experience difficulties adjusting to my host family, the program director will first try to assist me in the adjustment process. If I encounter problems of any kind while serving in the program, I will bring them first to the attention of the program director.
- 10. Perform community service.** I acknowledge that performing community service is considered in the United States to be a way of giving to others, not as punishment for the giver. I will willingly perform such community service as the program may direct.

11. Avoid trouble. I understand that I may not do any of the following or I will be dismissed from the program immediately, will forfeit refund of my deposit [U.S. Ambassadors], and I may be sent home early. Any expenses which result from the early termination of my participation will be the responsibility of my family or legal guardians. I will not:

- a. Use alcohol, tobacco or illegal drugs.
- b. Drive a motorized vehicle requiring an operator's license while living with a host family.
- c. Steal, shoplift or otherwise violate the law.
- d. Engage in sexual conduct.
- e. Intimidate, coerce or bully others nor be physically violent.
- f. Be verbally abusive.

12. Abide by the sexual harassment policy. Flirting, teasing and jokes can go too far, and some conduct is simply unacceptable. I will familiarize myself with the program's sexual harassment policy, and I will conduct my own actions in accordance with it. I will help other program members to understand it, and I will work to promote it. To that end, I will:

- a. Not sexually harass anyone.
- b. Get help if I am being sexually harassed.
- c. Help others if I see them being sexually harassed.

13. Respect others' faiths. I will recognize and respect that religions very different from my own may play important roles or no role at all in the lives of others in the program. To that end, I will:

- a. Offer any exposure to my religious practices to others in the program solely as demonstrations of the role faith plays in my life, without advocating any involvement in my religious practices by others beyond that of cultural observers, and then only to the extent to which they are comfortable.
- b. Accept exposure to religious practice of others in the program graciously, and endeavor to view them as insights into their lives and cultures.

14. Be a positive force. I will:

- a. Abide by the laws of my home and I will abide by the laws of the place I am visiting.
- b. Participate in all of the program orientation and training sessions.
- c. Familiarize myself with all of the materials made available to me by the program. I will be responsible for learning all of the rules, laws and regulations expected of anyone traveling to another country, whether or not such materials are provided by the program.
- d. Be on time for everything. I acknowledge that in America punctuality matters.
- e. Ask before I act. If I do not know the law or rules that apply, I will find out what they are before I engage in any activity.

SEXUAL HARASSMENT POLICY

1. Do not sexually harass anyone.

Sexual harassment is unwanted sexual behavior. It may take different forms, including:

- * Physical contact, like grabbing, pinching, touching someone's breast or butt or other body parts, or kissing them against their will;
- * Sexual propositions, like asking someone for sex or repeatedly asking them out when they have said no;
- * Sexual comments, like name-calling, starting rumors about someone, making sexual jokes at their expense, or making sexual gestures at or about them;
- * Unwanted communication, like phone calls, letters or e-messages. These can be mean, nasty, or threatening, or they can seem flattering or nice but still make the other person uncomfortable.

These are only examples; there may be other forms of behavior that are not listed here but still can be considered sexual harassment.

Both the harasser and the victim can be either male or female, and they do not have to be the opposite sex. The harasser can be another teenager or an adult.

Flirting is one thing. Harassment is another.	
Some flirting between kids is normal and healthy, but sometimes it can be hard to tell the difference between flirting and sexual harassment. The lists below can help you figure it out. (An adult flirting with a kid is not)	
Flirting Flirting is welcome attention. Flirting goes both ways. Flirting makes you feel flattered or attractive. Flirting makes you feel in control.	Sexual Harassment Sexual harassment is not wanted. Sexual harassment is one-sided. Sexual harassment makes you feel put down or ugly. Sexual harassment makes you feel powerless. Sexual harassment makes you feel bad or dirty.

If you think you are flirting with someone, but they do not respond the way you want them to, consider this...

- ◆ If the person does not seem happy with your attention,
 - ◆ If you flirt but they do not flirt back,
 - ◆ If you make a sexual joke and they do not laugh,
 - ◆ If the person seems to be avoiding you . . .

. . . you might be making them uncomfortable. The bottom line is that if the person receiving your sexual or romantic attention doesn't want it and you continue, that's harassment and you should stop it.

2. If you are being sexually harassed, get help.

If you are a victim of sexual harassment, you might . . .

- ❖ Feel angry, embarrassed, frustrated, scared or depressed
 - ❖ Feel hopeless that nothing can be done
 - ❖ Feel helpless to stop the harassment
 - ❖ Not feel good about yourself
 - ❖ Fear that your reputation will be destroyed
- ❖ Go out of your way to avoid the harasser(s)
- ❖ Experience headaches, stomach aches, or sleeping or eating problems because of the stress caused by the harassment

Because "sexual harassment" is a term that can describe many different behaviors, the kind of help available to you may differ, depending on exactly what the person harassing you has done. In most cases, the harassment will probably not constitute a crime, but rather be a violation of program rules (especially if there is no touching involved and no threats have been made). This means that it will be handled through program administration rather than the criminal justice system (police, court, etc.) In such a case, you can begin by following the steps:

- ❖ Tell the person harassing you that their behavior makes you uncomfortable and you want them to stop. You can do this face-to-face or in writing. If you write them a letter, save a copy of it for yourself. In some cases, this will be enough to stop the behavior. (If you don't feel comfortable doing this by yourself, you can ask a friend or an adult for help. Or just skip this step and begin with the next one.)
- ❖ If the person doesn't stop when you ask them to, look again at this sexual harassment policy. It can help you understand what behaviors are considered harassment.
- ❖ Report the harassment to the program administrator and/or tell a parent.

3. If you see someone being sexually harassed, help them.

If you see harassment happening, you can help put a stop to it.

- Refuse to join in.
- If you feel safe doing so, step in and interrupt the harassment.
- Tell an adult you trust. Don't be a bystander.
- Talk to the person being harassed and try to get them to talk to an adult. Offer to go with them.

I applied to participate in the PSC Youth Ambassador Exchange Program ("YAEP"). After consulting with my parent(s) or guardian(s), and to ensure full and safe participation for both me and the student that my family may host ("Guest"), I acknowledge and agree to the Terms and Conditions below.

This agreement and any related riders and addenda shall not become effective unless and until I receive a separate written notice advising me that I have been selected to participate in the YAEP, after which I timely return a completed and fully signed PSC Confirmation form.

I have read and initialed the Release of Liability in Section 10 of this Agreement and have read and signed the attached Alcohol and Controlled Substance Rider.

TERMS AND CONDITIONS

I. Ambassador's Responsibilities.

A. Participation. As part of my participation in the YAEP, I will be traveling to the Sister City where I will stay with a family in that Sister City ("International Host") for approximately three weeks during this upcoming summer. I acknowledge that PSC has the right to change the Sister City to which I am assigned to travel. I acknowledge that as a YAEP participant, I must attend all mandatory YAEP functions, including but not limited to, the Youth Ambassador Academy and PSC volunteering events, and that I may be hosting an ambassador from the Sister City or

another location at my home for approximately three weeks during this upcoming summer. I acknowledge that I am expected to participate in Phoenix-area YAEP events upon my return from the Sister City. I agree to submit all documents and payments required by the YAEP in a timely fashion in accordance with schedules published from time to time by PSC.

B. Code of Conduct. I understand that I am representing the City of Phoenix and will act accordingly. I understand that at all times while I am participating in the YAEP I will act with dignity and do nothing

which could bring shame to, nor reflect negatively upon, myself or the City of Phoenix.

To that end, I have read, signed and will abide by the Youth Ambassador Exchange Program Code of Conduct and the Sexual Harassment Policy as adopted by PSC from time to time (the "Code of Conduct"). I agree that my obligations under the Code of Conduct are considered to be additional terms of this Agreement. I understand that PSC will treat any failure to abide by the Code of Conduct as a serious breach of this Agreement.

I agree to abide by any additional rules as established by PSC from time to time. I also agree that I will abide by United States and Arizona law, *even while in the Sister City*, as well as all laws that apply where the Sister City is located. I will similarly abide by the reasonable rules of the host family with whom I am staying and those of PSC's organizational counterpart in the Sister City.

I agree that if I host any gathering in my home that is attended by YAEP participants, I will ensure that all attendees of the gathering, whether or not YAEP participants, abide by all applicable laws, the Code of Conduct and any additional rules as established by PSC from time to time. Additionally, if I invite any person who is not a YAEP participant to any gathering attended by YAEP participants, regardless of whether such gathering is YAEP sponsored or related, I will ensure that such person abides by all applicable laws, the Code of Conduct and any additional rules as established by PSC from time to time.

C. Being a Host. I acknowledge and accept responsibility for the well-being, safety and activities of Guest. To that end, I will use my best efforts to 1) help him or her understand and abide by our laws, the Code of Conduct and other rules that may be established by PSC from time to time; 2) make Guest's visit to Phoenix rewarding and enjoyable for him or her; 3) know the whereabouts of Guest at all times; 4) assure that Guest is oriented and in contact with me or with other responsible members of the YAEP group at all times; and 5) assist with putting on YAEP events in Phoenix.

D. International Host. I acknowledge that my International Host may be of another race, religious preference or sexual orientation who may have only minimal ability with my language, and who may have customs with which I am unfamiliar. I acknowledge that I am expected to use my best efforts to adapt to

these differences and PSC will not be liable for any expenses incurred by me or Parent due to my unwillingness to adapt to these differences. In the event that my International Host is not fulfilling its duties under the YAEP by not providing adequate lodging, meals or transportation or I have an unresolvable conflict with them, I will contact PSC immediately and PSC will take reasonable steps to attempt to resolve the problems or try to have me placed with another host in the Sister City.

2. Expenses.

A. Deposit. I will pay PSC a deposit of \$325.00 (the "Deposit"), due within 10 days of the execution of this agreement. PSC will use \$225.00 of the Deposit will serve as confirmation of my participation in the YAEP. PSC will return the remaining \$100.00 to me upon my successful completion of the YAEP. This Deposit may be forfeited upon my breach of this Agreement, and the determination regarding whether the Deposit is refundable is at the sole discretion of PSC.

B. Airfare. I understand that I will be traveling to the Sister City by airplane and that PSC will make all arrangements for air travel on my behalf. I understand that PSC will be pay for the cost of my airfare, which amount I will pay to PSC when billed. However, in the event that I incur additional travel expenses for any reason not attributable to the gross negligence of PSC, including but not limited to, my missing my flight to the Sister City or returning home from the Sister City, or my returning early due to misconduct or otherwise, I acknowledge that I will 1) be responsible for any additional costs; and/or 2) reimburse PSC for any contributions it has made toward my airfare.

C. Passport, Visa and Immunization. I am responsible for timely obtaining a passport and all passport related expenses. PSC will obtain any visa that may be required for my travel in or to the Sister City. I am responsible for obtaining any immunizations required in order to travel to the Sister City. I agree to provide PSC with a copy of documentation of my immunizations and will carry a copy of this documentation with me when I travel to the Sister City in order to help medical personnel in the event I require medical treatment during my stay in the Sister City.

D. **Scholarships.** In the event that I receive a scholarship, I understand that I will have additional YAEP responsibilities. These responsibilities include, but are not limited to, writing a thank you note to my sponsor, sending personalized invitations and post-cards to my sponsor and arranging meet-and-greets with my sponsor. I understand that if I do not complete these and all other reasonable requirements of the scholarship I am awarded, I may be required to forfeit my scholarship and repay PSC any scholarship money already contributed toward my participation in the YAEP.

3. **Travel.** I understand that, while PSC will provide instructions for my travel and will make all arrangements for my travel to and from the Sister City, PSC will not be liable for any harm resulting from an unforeseen event that occurs during my travel. Unforeseen events include, but are not limited to, my missing a flight connection, cancelled flights, delays, International Host's failure to provide my transportation to or from the airport in the Sister City and my failure to pass through customs. I agree to travel to and from the Sister City when and how I am scheduled.

4. **Insurance.** PSC makes available traveler's and baggage insurance for me that will provide coverage for unexpected travel expenses, such as emergency medical expenses and lost baggage ("Traveler's Insurance"). I agree to subscribe to the Traveler's Insurance and to pay PSC the applicable insurance premium for the coverage and to pay the amounts of applicable deductibles or co-payments, if any. I further agree to fully cooperate with PSC and its insurer in the event a claim or incident that could result in liability to PSC occurs. Nothing in this paragraph prevents me from obtaining additional travel or medical insurance coverage of my choosing.

5. **Travel Advisory Waiver.** I have reviewed the Travel Warning Advisories, if any, available from the United States State Department in regard to the Sister City. I acknowledge that I have had the opportunity to ask questions and seek advice from third parties concerning safety and security issues concerning travel in the areas in which I may be traveling. I agree to assume all risk of harm, including personal injury, my death or the loss of or damage to my property, which may arise incident to my travels to, from, within and about the Sister City.

6. **Customs.** I will abide by all customs regulations of the United States and of the nation(s) I visit, including the customs regulations of any nation in which I make a connection or a stopover. I acknowledge that in the event I have problems at Customs, PSC will not be liable for any harm that may occur as a result.

7. **Personal Information.** I acknowledge and agree that PSC may disclose my entire YAEP application to my International Host and to PSC's counterpart organization in my Sister City, and that PSC may further disclose my name, address, email address and telephone number to current and future participants in the YAEP. Additionally, I acknowledge and agree that I may be photographed or recorded during my participation in YAEP activities and I give PSC all right, title and interest in such photographs, and the right to publish my name and likeness in connection with published materials, promotions and public relations on behalf of the YAEP and/or PSC. I understand that my likeness will only be used to further the cultural exchange mission of the YAEP. I hereby grant PSC, its successors, and those acting with its authority and permission the irrevocable and unrestricted right and permission to copyright, in its own name or otherwise, and to use, re-use, publish and re-publish pictures of me or in which I may be included, in whole or in part, whether clear, distorted or altered, and reproductions of such pictures, through any medium, for illustration, promotion, art, editorial, advertising or other legal purpose. I also consent to any printed matter used in conjunction with such images. I waive any right to review or pre-approve any such use, and I hereby release and agree to hold PSC, its successors, and those acting with its authority and permission harmless from any liability for use of such images or due to alteration, distortion, optical illusion or composition, whether intentional or otherwise.

8. **Consent to Criminal Background Check.** I acknowledge and agree that, if I am age 18 or over, PSC may run a criminal background check on me. I agree to provide PSC with my social security number and any other personal data that may be necessary in order to effectuate such a check. I further agree that PSC may terminate my participation in the YAEP based upon information disclosed by such background check, the determination of which is solely at the discretion of PSC, and is without regard to actions taken in the past with respect to other program participants.

9. **False Information.** I acknowledge that if application information submitted by me or by my parent(s) and/or guardian(s) is found to have been false, PSC may a) dismiss me from the YAEP; b) require me to forfeit my Deposit; c) require me to reimburse PSC for all PSC's contributions toward my participation in the YAEP and/or d) require me to reimburse PSC for any scholarship I may have been awarded.

10. **Release of Liability.** In consideration of PSC's undertaking of the responsibilities and liabilities discussed in this agreement, I, on behalf of myself, my parent(s)

and/or guardian(s), my heirs, or personal representatives, do here now and forever release, discharge, hold harmless and indemnify PSC, the City of Phoenix and their respective agents, volunteers, contractors, subsidiaries, affiliates, successors, shareholders, officers, directors, representatives and employees from any and all liability, claims, demands, damages, rights of action or causes of action, present or future, arising out of or connected with my participation in the YAEP, including any injuries or death that may result. I understand that PSC takes great care to send its Youth Ambassadors to safe places and to place them into safe situations; however, I also understand that PSC cannot and does not promise or guarantee my safety and security from injury or loss, or against the effects of the criminal actions of others. Furthermore, I agree that PSC will not be liable for any damage or injury to me or my personal property arising from casualty or theft occurring while I am participating in the YAEP. I agree to indemnify PSC and hold it harmless from all claims, costs and expenses arising from injury to me or to my property. **I acknowledge and agree that I am responsible for protecting myself and my belongings.**

I ACKNOWLEDGE THAT I HAVE THOROUGHLY READ THIS SECTION IN ITS ENTIRETY AND FULLY UNDERSTAND THAT IT IS A RELEASE OF LIABILITY. BY SIGNING THIS DOCUMENT AND INITIALING THIS CLAUSE, I AM WAIVING ANY RIGHT I, MY PARENT(S) AND/OR GUARDIAN(S) OR MY SUCCESSORS MIGHT HAVE TO BRING A LEGAL ACTION OR TO ASSERT A CLAIM AGAINST PSC OR THE CITY OF PHOENIX FOR ITS NEGLIGENCE OR THAT OF ANY AGENTS, CONTRACTORS, VOLUNTEERS, OFFICIALS OR EMPLOYEES. I ACKNOWLEDGE THAT I AM SIGNING THIS FORM FREELY AND VOLUNTARILY, AND I EXPRESSLY INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.

II. **Indemnity.** I indemnify PSC against, and will pay on behalf of PSC, Losses in any Proceeding brought as a result of my participation in the YAEP or as a result of my breach of this Agreement. I will indemnify PSC to the full extent authorized or permitted by Arizona law. For purposes of this Section 12:

“Losses” means all expenses (including attorney’s fees), damages, judgments, fines and amounts paid in settlement actually and reasonably incurred by PSC;

“Proceeding” means any threatened, pending or completed civil, criminal, administrative, or investigative action, or suit; and

“PSC” means PSC, its employees, agents and volunteers.

A. Exclusions from Indemnification. I will not indemnify PSC if liability arises as a result of PSC’s willful misconduct or gross negligence or if Arizona law prohibits indemnification. I am not obligated to indemnify PSC in connection with a Proceeding initiated by PSC unless the Proceeding was authorized or permitted by me or the Proceeding is to enforce a right to indemnification under this Agreement.

B. Notice. PSC will promptly notify me in writing of a Proceeding and will provide reasonable cooperation and authority to defend or settle the Proceeding.

C. Settlement. I am not obligated to reimburse the costs of a settlement unless I have agreed to the settlement.

D. Offset for Other Payments. I am not liable to make any payment under this Agreement for a Loss if the Loss is paid on my behalf from insurance or any other source.

E. Attorney’s fees. If either I or PSC bring an action to enforce rights or to collect monies due under this Section 12, the prevailing party is entitled to recover reasonable fees and expenses, including attorney’s fees, costs and expenses, incurred in such action.

12. **Default.** I understand that if I fail to fulfill my responsibilities under this Agreement, PSC may a) dismiss me from the YAEP (which may result in my immediate return from the Sister City at my own expense); b) require me to forfeit my Deposit; c) require me to reimburse PSC for all its contributions toward my participation in the YAEP; d) require me to reimburse PSC for any scholarship I may have been awarded and/or e) impose other reasonable forms of discipline, including but not limited to requiring me to volunteer time to PSC in addition to what is already required by the YAEP. I understand that PSC may take these actions without regard to disciplinary actions taken by PSC at any time with respect to others.

13. **Governing Law; Amendment; Assignment.** This Agreement will be enforced in accordance with Arizona law. This Agreement may be amended only by a writing signed by both parties. This Agreement is not assignable by either party.

14. Entire Agreement. This constitutes the entire agreement between me and PSC and supersedes all prior agreements, understandings and representations relating to the same subject matter, whether written or verbal.

16. Force Majeure. PSC will not be liable for any failures in performance due to circumstances beyond its reasonable control which could not be avoided by the exercise of due care.

15. Severability. If a term, provision, covenant, agreement or condition of this Agreement is held to be void, invalid or unenforceable, the same will not affect any other portion of this Agreement and the balance of the Agreement shall remain in full force and effect.

17. Number, Gender. When the context of this Agreement requires, the gender of all words shall be deemed to include both the masculine and the feminine and the number of all words shall include the singular and plural.

4. **Conduct,** I agree that if I host any gathering in my home that is attended by YAEP participants, I will ensure that all attendees of the gathering, whether or not YAEP participants, abide by all applicable laws, the Code of Conduct and any additional rules as established by PSC from time to time. Additionally, if I or Ambassador invite any person who is not a YAEP participant to any activity attended by YAEP participants, regardless of whether such event is YAEP sponsored or related, I will ensure

that such person abides by all applicable laws, the Code of Conduct and any additional rules as established by PSC from time to time.

5. **Medical Care.** In the event that Ambassador requires medical care, including vision and/or dental care ("Medical Care") while participating in the Program, either Ambassador or I shall notify PSC as soon as possible, and I authorize PSC to either a) contract for Medical Care; or b) confer their right to secure Medical Care for Ambassador to their organizational counterpart in the Sister City. In the event that Ambassador requires emergency Medical Care while in the Sister City, I give International Host and/or PSC's international organizational counterpart permission to seek emergency Medical Care for Ambassador. I understand that while PSC has asked International Host to contact PSC before seeking non-emergency treatment for Ambassador. PSC cannot be held liable for any harm that may occur to Ambassador in the event that International Host or PSC's international organizational counterpart does not do so. I understand that this authorization is given in advance of any specific diagnosis, treatment or hospital care, and that it is given to provide International Host and PSC the authority to seek necessary medical treatment for Ambassador. I understand that whenever possible, PSC will make a good faith effort to contact me before seeking medical treatment for Ambassador. If this is not possible, I understand that PSC will notify me as soon as possible of any and all occur-

rences necessitating medical treatment, as well as all diagnoses and treatments. In all events, I acknowledge that I am financially responsible for all medical costs incurred.

6. **Financial Aid.** I certify that any information I provide on the YAEP Financial Aid Application is true. I understand that if PSC learns that any of the information in the application is false, I will be in default of this Agreement.

7. **Release of Liability.** In consideration of PSC's undertaking the responsibilities and liabilities discussed in this agreement, I, on behalf of myself, my heirs, or personal representatives, do here now and forever release, discharge, hold harmless and indemnify PSC, the City of Phoenix and their respective agents, volunteers, contractors, subsidiaries, affiliates, successors, shareholders, officers, directors, representatives and employees from any and all liability, claims, demands, damages, rights of action or causes of action, present or future, arising out of or connected with Ambassador's participation in the YAEP, including any injuries or death that may result. I understand that PSC takes great care to send its Youth Ambassadors to safe places and to place them into safe situations; however, I also understand that PSC cannot and does not promise or guarantee the safety of Ambassador and security from injury or loss, or against the effects of the criminal actions of others. Furthermore, I agree that PSC will not be liable for any damage or injury to Ambassador or Ambassador's personal property arising from casualty or theft occurring while Ambassador is participating in the YAEP. I agree to indemnify PSC and hold it harmless from all claims, costs and expenses arising from injury to Ambassador or to Ambassador's property.

TERMS AND CONDITIONS

1. Background. I have agreed to participate in the PSC Youth Ambassador Exchange Program (the “YAEP”), in which I will allow a youth from a Phoenix Sister City (“Guest”) to stay with me and others in my household for approximately three weeks. To ensure full and safe participation for me, my family and Guest, I enter into this Agreement.

2. Host’s Responsibilities.

I acknowledge that the YAEP is based on an exchange host family system. I confirm that I (and each of us) for myself, and on behalf of every member of our household, am committed to and am able to host a Guest for approximately three weeks during this upcoming summer, on a schedule to be determined by PSC. I acknowledge that hosting includes but is not limited to providing lodging, meals and transportation to and from YAEP-sponsored events for Guest. I am willing to accept a Guest into my home who may be of another race, religious preference or sexual orientation, who may have only minimal ability with our language, and who may have customs with which I am unfamiliar.

I agree that I will take Guest out of the Phoenix Metropolitan area only if a) it is in connection with a YAEP-

sponsored activity; or b) I have the express consent of PSC and such travel conforms with YAEP rules for out of town travel with Guests.

I and other members of my household understand that we are representing the City of Phoenix and will act accordingly. To that end, I agree that I will make a concerted effort a) to ensure that Guest’s stay in my home is a positive and memorable experience; and b) to cause other members of my household to make a similar effort. I understand that failure to do so may result in my dismissal from the YAEP.

3. Conduct. If 1) such individuals refuse to do so, 2) I reasonably fear that my asking them to do so will result in violence, or 3) I reasonably believe that such individuals will drive a vehicle while under the influence of alcohol or an illegal substance, I agree to call the police. **I understand that even if my fulfill my responsibilities under this Agreement, I may have different or additional responsibilities under the law.** In all events, I will immediately report any incident involving the use of alcohol or illegal substance by the persons listed above to my PSC contact person whenever I witness such use or learn of it.

I understand that my failure to fulfill my responsibilities under this Agreement will likely result in my and my child's expulsion from the program. I acknowledge that whatever action is taken by PSC as a result of such a failure by me will be without regard to actions taken by PSC in respect to failures by others in this situation or in past situations.

I also understand that any Loss that results from such failure is a Loss as defined in Section 10 of the Host Agreement and that I will be responsible for indemnifying PSC for such Losses. **THIS MEANS THAT IF ANY OF THE PERSONS LISTED ABOVE INJURES ANOTHER PERSON OR CAUSES DAMAGE TO PROPERTY BE- CAUSE THEY ARE UNDER THE INFLUENCE OF DRUGS OR ALCOHOL, I WILL BE HELD RESPON- SIBLE FOR ANY LOSSES THAT RESULT!**
